interacted with *three* generations of the same family, regularly providing them with market insight from both a buyer's perspective and a seller's perspective. During a conversation with the seller earlier this year, we determined the time was right to sell the facility. We also agreed that sellerfinancing would help the seller get the highest value for the facility, maintain a steady monthly income stream, partially defer capital gains taxes, and pursue other investment opportunities. During a brief two-week marketing period, we were able to generate eight offers, five of which exceeded our list price. Three of the offers came from Texas-based investors, and the other offers came from buyers that were based in Utah, Illinois, Virginia, Pennsylvania, and Minnesota. We selected a buyer, and worked with them hand-in-hand to close the deal at the contracted price within the original 60-day timeline".
